## **The Below Critical Due Process Lawful Notice & Message Concerns The Fact That Store "Access Discrimination" Against People That Don't Wear A Mask Violates The Law** (Please Share This With Others)

**Due Process & Equal Protection Must Apply For All Public Policy Orders On Wearing Masks**  
The courts have said civil commitments of any kind constitute significant deprivation of peoples liberties and require due process rights protection. US V. Mc ALLISTER, 225 F3d 982 (8th Cir. 2000). People must be afforded their due process rights before deprivation of liberty. ARMSTRONG V. MONZO, 380 US 545, 552, 14 LEd2d 62, 85 SCt 1187 (1965). Government officials violate due process when attempting to penalize people exercising statutory or constitutional rights. US V. CONKINS, 987 F2d 564 (9th Cir. 1993). Equal protection and due process guarantees apply to aliens as well as United States citizens. DOMOND V. I.N.S., 244 F3d 81 (2nd Cir. 2001).

### **There Can Be No Discrimination in "Public Accommodations Access" To Stores And Other Businesses**

Our laws say people who do not wear a mask because of health problems have a "Right" to equal protection and equal access to stores and other business facilities which are considered "Public Accommodations," per the constitutionally compliant ADA and Civil Rights Statutes, etc. The types of "Disorders" and "Impairments" covered by the ADA and other General Laws are, respiratory (COPD, Allergies, Asthma, etc.) systemic (diabetes) cardiovascular (heart disorders and stroke, etc.), neurological, special-sense organs, musculoskeletal, digestive, reproductive, hemic and lymphatic, endocrine, skin, genitourinary, orthopedic, speech, hearing and visual impairments, etc. In law "Rights" (or "Liberty Interests" which are a form of Rights) are considered as "Property." And people have a liberty interest or right to have "Equal Access" to stores, etc., which cannot be taken away, because a principle of law says, "What is mine (Equal Protection/Access, Rights/Property) cannot be taken away without my consent."

### **Businesses Cannot Discriminate Against People That Don't Wear Masks**

Just as we know people cannot be discriminated against because of their race or religion or age, etc. they also cannot be discriminated against for other reasons like health limitations or other reasons. That is a reason why the Supreme Court has ruled, "One must be ever aware that the Constitution forbids sophisticated as well as simple minded modes of discrimination." LANE V. WILSON, 307 US 368, 95 LEd 110, 59 SCt 872 (1951). Also, when it comes to health matters businesses cannot lawfully demand that people tell, what their medical condition is for not wearing a mask, or ask for people's Covid-19 testing status; to do so is a violation of ones rights to privacy in health matters according to law and the Health Insurance Portability and Accountability Act (HIPAA) rules, et al. The courts have said the right to privacy includes, but is not limited to, "individual interest in avoiding disclosure of personal matters." Doe V. DELIE, 257 F3d 309 (3rd Cir. 2001)

### **The Constitution Cannot Be Suspended In A Crisis/Emergency By Government Officials**

On Monday April 27, 2020 Attorney General Bill Barr issued a Memorandum directing Department of Justice prosecutors to act against authorities imposing lock-down measures that "could be violating the constitutional rights

**and civil liberties of individual citizens." Barr said "... the Constitution is not suspended in times of crisis. We must therefore be vigilant to ensure its protections are preserved,..."**

The courts have ruled that governors and other government officials cannot make laws in violation of their oath to uphold the constitution. The courts have said, **"No state legislator or executive or judicial officer can war against the Constitution without violating his undertaking (solemn oath) to support it."** Cooper v. Aaron, 358 U.S. 1, 78 S.Ct. 1401 (1958). The Fifth Circuit Appeals court has said, **The government cannot prohibit or control the conduct of people for reasons that infringe upon freedoms that are constitutionally guaranteed.** Smith v. U.S. 502 F 2d 512 CA Tex (1974). **Government Officials can be held liable for constitutional wrong doing resulting from his/her failure to sufficiently train or supervise subordinates.** White v. Farrier, 849 F2d 322 (8th Cir. 1998).

**Furthermore, statutory businesses** (corporations, and the like) are creations of the state/government and **have no more power over people's conduct than the state.** The black letter law maxim principle of law says, **"The power which is derived cannot be greater than that from which it is derived."** Further private entities like corporations, stores, restaurants or other food and drink places, hotels, places of entertainment, health facilities, travel services, public buildings, parks, stadiums, convention centers, halls, or other places of public gathering, museums, etc., are considered 'public accommodations' for purposes of access and commerce, see Title 42 U.S. Code § 12181 (7).

**In a time of health crisis, or other types of crisis, government officials cannot just require people to forfeit their rights; or fine them and presume they give up their rights not to be fined for exercising their liberties, because the courts have said waiver of fundamental Rights will never be presumed, not ever.** OHIO BELL V. PUBLIC UTILITIES COMMISSION, 301 U.S. 292 (1937). Also, **"The claim and exercise of a Constitutional right cannot be converted into a crime."** Miller v. U.S., 230 F.2d. 486, 489.

#### **The American Medical Association Journal Notes Masks Are Not For Healthy People**

**Face masks should not be worn by healthy individuals** to protect themselves from acquiring respiratory infection **because there is no evidence to suggest that face masks worn by healthy individuals are effective in preventing people from becoming ill.** Face masks should be reserved for those who need them because masks can be in short supply during periods of widespread respiratory infection. Because N95 respirators require special fit testing, they are not recommended for use by the general public. The government can't lawfully punish people for not wearing a mask because due process of law is violated when the government attempts to penalize people for exercising protected statutory or constitutional rights. US V. CONKINS, 987 F2d 564 (9th Cir. 1993). **There can be no penalty imposed upon someone because of his or her exercise of Constitutional rights.** Sherar v. Cullen, 481 F 2d 945/6(1973). Also, **"He who uses his legal rights, harms no one."**

## Due Process Prevents Government Officials From Harming People

**Government mask mandates, vaccines, and violating rights can all be harmful and due process guarantees protect people against harm from government officials.** BROWN V. NATIONSBANK CORP, 188 F3d 579 (5th Cir 1999).

While most agree that the N95 mask can cause significant hypoxia and hypercapnia, another study of surgical masks found significant reductions in blood oxygen as well... **The importance of these findings is that a drop in oxygen levels (hypoxia) is associated with an impairment in immunity.** Studies have shown that hypoxia can inhibit the type of main immune cells used to fight viral infections called the CD4+ T-lymphocyte. This occurs because the hypoxia increases the level of a compound called hypoxia inducible factor-1 (HIF-1), which inhibits T-lymphocytes and stimulates a powerful immune inhibitor cell called the Tregs. . **This sets the stage for contracting any infection, including COVID-19 and making the consequences of that infection much graver. ## Workplace Covid-19 Regular Mask Wearing Illusion - OSHA Health and Safety Risks

**Believing masks will keep one safe and healthy is likely an illusion. People wearing masks have been found to lower the oxygen content that they are breathing in, at times below healthy limits** considering constitutionally compliant "Occupational Safety and Health Administration" (OSHA) standards for a safe workplace, **which is also unsafe for masked patrons in that workplace. Thereby, harming and not helping workers and patrons.**

**Human beings must breathe oxygen . . . to survive, and begin to suffer adverse health effects when the oxygen level of their breathing air drops below [19.5 percent oxygen].** Below 19.5 percent oxygen . . . , air is considered oxygen-deficient.
